This has reference to your application Id. No. 384 dated 18/07/2013 seeking accreditation by National Board of Accreditation to UG Engineering programmes offered by G. H. Raisoni College of Engineering and Management, Gat No. 1200, Domkhel Road, Wagholi, Tal. Haweli, Dist. Pune – 412 207 (Maharashtra).

2. An Expert Team conducted on-site evaluation of the programme during 22nd to 23rd October, 2016. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The competent authority in NBA has approved the following accreditation status to the programme as given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The program has been granted provisional accreditation. G. H. Raisoni College of Engineering and Management, Gat No. 1200, Domkhel Road, Wagholi, Tal. Haweli, Dist. Pune – 412 207 (Maharashtra) should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above. It may require submission of pre-qualifier before sending the Compliance report for granting further Accreditation.

5. The accreditation status awarded to the programme as indicated in the above table does not imply that the accreditation has been granted to G. H. Raisoni College of Engineering and Management, Gat No. 1200, Domkhel Road, Wagholi, Tal. Haweli, Dist. Pune – 412 207 (Maharashtra) as a whole. **As such, the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is programme accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the programme(s) accredited, level of programmes and the period of validity of accreditation, as well as the date from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

7. The accreditation status awarded to the programme as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
